QUALITY IMPROVEMENT PROGRAM GUIDELINES

This document, contains a comprehensive, detailed description of the steps to compile and implement a Quality Improvement Program. This document was prepared to assist member and non-member facility providers to comply with Section 1800 of Regulation 61-84. This document is intended as a guide in preparing a Quality Improvement Program for your home or community. We encourage you to have DHEC review your plan to ensure it meets the regulatory requirements and is well suited for your individual home or community.

MODEL EMERGENCY PLAN

Regulation 61-84 requires all operators of a licensed community residential care facility to have an Emergency Plan in place including information about evacuation and sheltering. SCARCH developed this plan to guide providers in meeting this regulation.

This Model includes a checklist to ensure all required information is included along with specific information needed in case of an emergency. Also, included is information on emergencies we might never consider such as heat wave, chemical spill or an earthquake.

MEDIA RELATIONS & CRISIS MANAGEMENT FOR AL

Do you know what to do if you had a crisis? Do you know how to handle the media? Do you know the steps in preparing a crisis communications plan? This manual will help you understand the importance of a crisis management program and will help you develop a plan that will work for your home or community
